

## **Radiation Effects Research Foundation Summary Report of the 15th Meeting of the RERF Board of Councilors**

The 15th Meeting of the RERF Board of Councilors was convened at the Hiroshima Laboratory on June 18 and 19, 2025.

The main topics and results of the discussions are as follows.

### **I. Report of Activities and Settlement of Accounts**

The implementation status of FY2024 activities was conveyed using reports of activities (international collaborative activities, including joint projects with overseas institutions), settlement of accounts report, audit reports and related statements, and approved without objection.

### **II. Plans of Activities, Budget Estimates and Related Matters**

Reports were given on the FY2025 plans of activities for research projects examining A-bomb survivors' health, research projects on the health of A-bomb survivors' children (F1), research to elucidate individual radiation doses and the effects from the A-bombs, projects to release research results and to collaborate with other scientific organizations, training programs for domestic and overseas specialists, public information programs, and other activities. Operating budgets for the plans were also shared.

### **III. RERF Strategic Plan and Plan for the Relocation of Hiroshima Laboratory**

The strategic plan and implementation activities for achieving the mission assigned to RERF were explained, as was the progress of the relocation to the Kasumi Campus of Hiroshima University. This was followed by a discussion.

### **IV. Recommendations of the Scientific Advisory Committee and Responses to the Recommendations**

The Scientific Advisory Committee held its 52nd meeting over three days from March 3 to 5, 2025, to conduct reviews with a focus on the cross-departmental Trio Genome Study and the Department of Epidemiology. Regarding the Trio Genome Study, it was confirmed that preparations for starting full-scale analysis were complete; and it was determined that epidemiology studies assessing risk of cancer and non-cancer diseases among A-bomb survivors and their children are making steady progress. The BOC discussed various SAC recommendations and RERF's responses to them. For example, the planned use of new dose assessment methods that consider age, sex, anatomical information of organs, and other factors are expected to lead to more precise evaluations of radiation effects in the future.

### **V. Appointment of Directors, Councilors, and Scientific Advisors**

The BOC appointed successors to the Directors, Councilors, Scientific Advisors, and Local Advisors whose terms will expire after the current meeting. The BOC also appointed one external Director, a position that has been newly obligated to be established. The terms of office will be held until the end of the BOC meeting (regular) held in the year specified in the parentheses “( )” of the attached documents.
