Assessment of arteriosclerotic diseases and their risk factors," the sentence "If necessary, physicians will review the medical charts" should be changed to "If necessary, physicians will review the medical charts of RERF." 3. On page 13, ensure that the study participants and their related parties have the opportunity to opt out by posting the Information Disclosure Form on the RERF website, stating that the information, including AHS health examination information, cancer registry information, mortality information, and LSS questionnaire information, will be used for the study. 3. On page 16, under "2) Association of radiation dose with lipid level," the period of cross-sectional study should be confirmed and modified if necessary. 4. On page 16, under "3) Investigation of the potential underlying pathways linking radiation dose to glucose and lipid metabolism," as for item "d) IGF-1 and IGFBP-3", it should be stated that the data is obtained from the previous research protocol. 5. On page 20, under "Ethical Considerations," in the sentence "Only existing AHS data will be used in this study," the word "existing" should be deleted, and it should be specifically stated that information, including AHS health examination information, cancer registry information, mortality information, and LSS mail survey information, will be used. Because consent to use some of the information (e.g., cancer registry information and mortality information) for the study has not been obtained, add the sentence that the Information Disclosure Form will be posted on the RERF website to provide the study participants and their related parties with the opportunity to opt out. 4. On page 20, change "personal identification number for the research (Sys ID)" to "system ID number (sysid) used for the research analysis database." Change the sentence, "We strive to maintain a secure information system to protect personal information." to "Data analysis is performed only within RERF, where a

		personal information." It should also be stated that no data will be provided to the outside
		collaborators.
		• On page 21, under "Ethical Considerations," the personal information manager should
		be changed from the co-chairperson of the Institutional Review Board to the general
		personal information privacy protection officer.
